

Terms and Conditions

1. These Terms and conditions form part of an agreement between you and Berkhamsted School Activity Camp for purchase of a holiday for a child or children. Confirmation of your booking will follow after receipt of your booking form plus the appropriate fee. Payment of the fee is regarded as evidence of your acceptance of the terms and conditions.
2. Cancellations of your booking, for whatever reason, must be notified immediately to us in writing.
3. Bookings are not transferable to other children.
4. Certain activities may take place off site. Children will participate in these activities unless we specifically receive written notification from parents/guardians to the contrary.
5. We reserve the right to exclude or refuse admission at any time prior to and during the holiday if, in our opinion, that person is incompatible with the general well being of and enjoyment of others. Any additional costs will be at the expense of the person acting 'in loco parentis' and no refund will be made.
6. The organisers reserve the right to amend the programme where this is found to be necessary.
7. Berkhamsted School Activity Camp reserves the right to use photographs taken during camp in any advertising material. The photographs, negatives and films are the property of Berkhamsted School Activity Camp.
8. Berkhamsted School Activity Camp, its servants, agents and employees are not under any liability whatsoever in respect of personal injury, sickness, loss or damage caused to Course Members.
